Previously, the university had issued a notification inviting online applications for combined admission into various undergraduate courses of PJTAU, PVNRTVU, and SKLTGHU under both the regular and self-financing quotas. Because of the increased demand for agricultural courses and to encourage rural youth to pursue agricultural education, the university has decided to increase the seat intake of B.Sc. (Hons) Agriculture course at PJTAU by an additional 200 seats under the self-financing quota, which will now be referred to as the **SPECIAL QUOTA**. Further, the fees of all UG courses of PJTAU under the Special quota have been reduced from ₹10 to ₹ 5 lakhs and that of SKLTGHU from ₹ 9 to ₹ 5 lakhs. The total intake under various UG courses of PJTAU, PVNRTVU, and SKLTGHU under Bi.P.C stream is given under.

@ The selection of the candidates for admission into B.Sc. (Hons.) Agriculture, B.Sc. (Hons.) Community Science, B.Tech. (Food Technology) and B.Sc. (Hons.) Horticulture courses under Special Quota shall be based on the ranks obtained in Telangana State EAPCET-2024 duly following the rule of reservation with fee structure as indicated in the prospectus. The rule of reservation under farmer's quota (@ 40%) will also apply for Special quota seats.

* 44 seats included above subject to the approval of Veterinary Council of India for admissions for the Academic Year 2024-25.

Sharing of seats as per A.P Reorganization Act is subject to orders of Government of Telangana.

Eligibility:

- A pass in two-year Intermediate Examination conducted by the Board of Intermediate Education, Telangana State or any other examination recognized as equivalent thereto by the University or Intermediate Board with the following subjects namely:
 - i) Physical Sciences
 - ii) Biological Sciences
- **A candidate for admission under general category to B.V.Sc. & A.H. degree course, must have passed in each of the subjects of English, Physics, Chemistry & Biology, and obtained 50% (47.5% for SC/ST/PH category i.e., 5% less than that prescribed for general category) of marks at intermediate or its equivalent examination.**

Criteria for selection:

- The selection of candidates for all the seats shall be made on the basis of ranks obtained by the candidates in the **Telangana EAPCET-2024** [Including Special quota seats in B.Sc. (Hons.) Agriculture, B.Sc. (Hons.) Community Science, B.Tech. (Food Technology) and B.Sc. (Hons.) Horticulture courses] conducted by the **Telangana Council for Higher Education**.
- In case of a tie in ranks obtained by two or more candidates in the Telangana State EAPCET-2024, the marks secured in the optional subjects of the qualifying examination (Intermediate or its equivalent) shall be taken into consideration. In case of a further tie, the age of the candidate shall be taken into consideration and the older candidate shall be given preference.

Age:

- The candidates for admission to B.V.Sc. & A.H. course shall be required to have completed 17 years of age with an upper age limit of 25 years for all the candidates, 30 years in respect of BC, SC and ST candidates as on 31st December of the year of admission.
- The candidates for admission into B.Sc. (Hons.) Agriculture, B.Sc. (Hons.) Community Science, B.Tech. (Food Technology), B.Sc. (Hons.) Horticulture and B.F.Sc. courses shall be required to have completed 17 years of age with an upper age limit of 22 years for all the candidates, 25 years in respect of SC and ST candidates; and 27 years for Physically Challenged candidates as on 31st December of the year of admission.

Reservation of seats for the candidates coming from families of Agriculturist cum Rural Area (Farmers' Quota) in B.Sc. (Hons.) Agriculture (Regular & Special Quota), B.Sc. (Hons.) Horticulture (Regular & Special Quota), B.Tech. (Food Technology) (Regular & Special Quota), B.V.Sc. & A.H. & B.F.Sc. courses:

- **Forty per cent (40%) of the seats in the PJTAU & SKLTGHU and 25% in PVNRTVU are reserved for candidates coming from families of Agriculturists (Farmers) owning not less than ONE acre of land either in the name of the parents or in the name of the candidate and who have studied for a minimum of 4 years in schools located in Non-Municipal areas during their period of study from 1st class to 12th class / Intermediate.**
- **If the land is owned by grandfather, grandmother or guardian or any other relations is not acceptable under farmer quota.**

- **ANNEXURE-I:** It is a proforma to be certified by **the Head Master** of the School with his office seal that the candidate has studied for a **minimum period of four years in schools located in Non- Municipal areas** during their period of study from 1st class to 12th class / Intermediate (**Non- Municipal Area Certificate**).
- **ANNEXURE-II:** It is a proforma indicating the patta numbers and extent of land owned by the **candidate / parents** duly certified by **the Tahsildar with his office seal (or)** the candidate has to upload attested photocopies of **pattadar pass book** as evidence of the extent of agricultural land.
- **ANNEXURE-I and ANNEXURE-II** need to be filled in with the **signatures of concerned officials viz., concerned Head of Institution and Tahsildar, respectively**, along with office seal. Otherwise, the claim of the candidates under this category will be summarily rejected.

Reservation of seats for the candidates coming from Rural Area (Rural Quota) in B.Sc. (Hons.) Community Science (Regular& Special quota) course:

- **Forty per cent (40%) of the seats** are reserved for candidates who have studied for a **minimum of 4 years in schools located in Non-Municipal areas**.
- **ANNEXURE -I:** It is a proforma to be certified by **the Head Master** of the School with his office seal that the candidate has studied for a **minimum period of four years in schools located in Non- Municipal areas** during their period of study from 1st class to 12th class / Intermediate (**Non- Municipal Area Certificate**) (**ANNEXURE – I**).
- **ANNEXURE -I** need to be filled in with the **signatures of concerned officials viz., concerned Head of Institution respectively**, along with office seal. Otherwise, the claim of the candidates under this category will be summarily rejected.

Residential Certificate:

- Applicants who have gap/break in the years of study for reasons other than failure or those who passed the qualifying examination by private study have to submit this certificate issued by the Tahsildar. In case, the applicant has resided in more than one place, separate certificate from the Tahsildar, should be furnished for such places of residence.

Reservation of Seats:

The rule of reservation (OC:46%, EWS:10%, BC-A:7%, BC-B:10%, BC-C:1%, BC-D:7%, BC-E:4%, SC:15%, ST:10%) will be followed as per the rules (**The rule of reservation in respect of EWS will be followed as per the guidelines issued by the Government of Telangana from time to time**).

Reservation of Special category seats:

The counselling for the **Physically Challenged (PH @5%*)**, **Children of Armed Personnel (CAP @2%)**, **National Cadet Corps (NCC @1%)** & **SPORTS (@0.5%)** quota seats shall be conducted in presence of the Officers of the departments concerned. The certificates of the candidates of above special categories shall be verified by the officers and the seats will be allotted as per the priorities indicated by them. The University has no interference in indicating priorities.

Note:

B. V. Sc. & A. H. course

In total intake of B.V.Sc. & A.H. course, **5%* of seats** are reserved for Physically Challenged /Handicapped quota.

Candidates with following disabilities **will not be admitted as per VCI (Veterinary Council of India) norms:**

1. Disability of total body including disability of chest or spine more than 50%.
2. Disability of lower limb of more than 50%.
3. Disability of upper limb.
4. Visually Handicapped Candidates and those with hearing disability.
5. Candidates with progressive diseases like myopathies etc.,
6. Disabilities which otherwise would interfere in the performance of the duties of a veterinarian.

*** Note: The implementation of 5% reservation for Physically Challenged /Handicapped quota is subject to further orders / guidelines issued by the Government of Telangana, otherwise the earlier 3% reservation under this quota shall be implemented.**

Reservation under Physically Handicapped Quota:

In various UG courses offered by PJTAU, PVNRTVU and SKLTGHU, 5% of seats are reserved for Physically Handicapped/Challenged candidates. The candidates seeking reservation under above quota will be required to be present himself/herself before a Selection Committee comprising of Residential Medical Officer, Specialists in the concerned fields of medicine and Deans of Faculty, who shall examine the suitability of the candidates to the various courses. As a part of the selection process, the candidates seeking admission into various UG courses of PJTAU, PVNRTVU and SKLTGHU will be required to perform the activities such as identification of slides through microscopes, operation of push/wheel hoes and walking on the bunds, spraying with knapsack/power sprayer, weeding & digging, irrigating the fields, reading from the blackboard, writing, threading the needle, hearing tests etc., as a part of the selection process.

Reservation under SPORTS Quota:

As per G.O.Ms No. 2 of the Govt. of Telangana dt. 22-09-2020, 0.5% of seats have been reserved under SPORTS quota. A total of 31 Sports Disciplines have been indicated in the said G.O. All the candidates who wish to seek admissions in various Under Graduate courses of PJTAU, PVNRTVU & SKLTGHU are required to upload a copy of his/her sports achievements/ testimonials along with the Form I, II, III & IV (whichever is applicable) duly certified/attested by the concerned State Sports Associations recognized by the SATS which are categorized according to level of the Championships. **Uploading of Form I, II, III & IV (whichever is applicable) is mandatory, otherwise the candidates will not be considered under Sports Quota.** The above Forms are also made available in the Online Admission application form.

- a. Form I For the International Championships (Medal & Participation) issued by the Federation
- b. Form II For Association National competitions (National/South Zone Medals/Participation and State Medals issued by the State Association
- c. Form III For the Universities Championships (Inter collegiate, South Zone University, All India / World Universities issued by the Universities)
- d. Form IV For SGF, Central Government schemes, for all remaining events like World/Asian school games, National / State level / Inter District games issued by the DEO / DYSO/Secy.SGF/ SATS official

The scrutiny of sports applications along with Form I, II, III & IV (as applicable) will be done by the competent authority and subsequently by an Evaluation committee for finalizing the priorities for allotment of the seats.

Reservation of seats for Women:

- In each course, 33 $\frac{1}{3}$ % of the seats shall be horizontally reserved in favour of women candidates from each category.

Allocation of seats:

- Out of total, 85% of the seats are reserved for local candidates and 15% of seats are Un-Reserved. **Note: The guidelines issued by the Government of Telangana from time to time shall be followed scrupulously including the reservations for 15% of seats under Un-Reserved quota.**

Hostel facility:

- **Hostel facility shall be provided subject to the availability of accommodation in the respective colleges.**

Original certificates to be produced at the time of counselling:

- SSC Memorandum of Marks or Equivalent Examination Certificate, showing the evidence of the Date of Birth.
- Pass Certificate cum Memorandum of Marks obtained by the applicant in the qualifying examination (Intermediate (10+2) or its Equivalent Examination).
- Telangana EAPCET-2024 Rank Card.
- Bonafide / Study Certificate from 6th to 12th Class.

- Transfer Certificate of the institute last studied.
- The certified copy of the Social Status Certificate issued by the competent authority of Telangana State in case of applicants belonging to Backward Classes, Scheduled Castes and Scheduled Tribes.
- The latest certified copy of the EWS Certificate valid for the year 2024-25 issued by the competent authority in case of applicants belonging to EWS category.
- Non-Municipal Area Study Certificate (ANNEXURE-I).
- Agricultural Land Holding Certificate (ANNEXURE-II).
- The certified copy Physically Challenged Certificate, if applicable.
- Children of Armed Personnel Certificate / Defence Personnel Certificate, if applicable.
- National Cadet Corps (NCC) Certificate, if applicable.
- Sports and Games Certificates along with Form I, II, III & IV (whichever is applicable) which are mandatory for claiming seat under SPORTS quota, if applicable.

- ❖ The candidates seeking admission under **SPECIAL QUOTA** (earlier Self-Financing quota) for **B.Sc. (Hons.) Agriculture / B. Sc. (Hons.) Community Science / B.Tech. (Food Technology)/ B.Sc. (Hons.) Horticulture** should bring **DD (Demand Draft)** in favour of **“Comptroller, PJTAU”** payable at Hyderabad for an amount of **Rs. 39,100/-** (Rupees thirty nine thousand one hundred only) and pay **Rs. 23,400/-** (Rupees twenty three thousand four hundred only) **in cash**.

The seats pertaining to Special Quota will be filled up through a separate counselling based on ranks obtained by the candidates in the Telangana EAPCET-2024 and rule of reservation.

- The rules and regulations with regard to eligibility, age, reservations etc., are the same for the Special quota that are applicable to the candidates admitted under general quota.
- The candidates selected under Special quota will be treated on par with regular students. No special amenities or facilities will be provided.
- **The Special quota seats in B.Sc. (Hons.) Agriculture, B.Sc. (Hons.) Community Science, B.Tech. (Food Technology) and B.Sc. (Hons.) Horticulture will be filled by separate counselling after filling up of regular seats.**
- The unfilled seats under Special quota will not be filled up from any other stream and will be kept vacant.
- **The candidates admitted under this quota are not eligible for any reimbursement of fee or educational concessions offered by the Government.**

- **In the event of establishment of new colleges such seats will also be considered for filling up through this notification only.**
- The Counselling/Verification under special categories (PH, CAP, NCC & SPORTS) will be held in the presence of authorities concerned and seats will be allotted as per the priorities indicated by the officers concerned.
- **If the admitted candidate cancels/withdraws his/her seat before the closure of admission process, the entire fee collected from the student shall be refunded in full after deducting Rs 1000/- (@ Rs. 5000/- for Special quota) as processing fee.**
- **Any cancellation/withdrawal of admissions after the closure of admission process, the candidate shall forfeit the entire fees (Except the caution deposits) in addition, the candidate has to pay the Rs. 1000/- (@ Rs. 5000/- for Special quota) as processing fee.**
