The University, vide reference 2nd cited, has implemented the Revised Pay Scales, 2020 to the Non-Teaching Staff with effect from 1.7.2018 notionally, with monetary benefit from 01.04.2020.

- 2) In the said Proceedings, it has also been ordered that the arrears of salary the Revised Pay Scales, 2020 for the period from 01.04.2020 to 31.03.2021 shall be paid at the time of superannuation of the concerned employee or to the legal heirs in case of demise of the employee. The arrears for the period from 01.04.2021 to 31.05.2021, will be paid during the financial year 2021-22 which will be issued separately on receipt of orders from the Government and the salary in the Revised Pay Scales, 2020 will be paid in cash from the month of June, 2021 payable in July, 2021 onwards. Further, it was also ordered that the orders with regard to admitting the pay in the Revised Pay Scales, 2020 and payment of arrears shall be issued separately.
- In continuation, the University, vide reference 3rd cited issued orders to admitted in the salary of Non-Teaching employees from the month of September, 2021, payable on 1st October, 2021 onwards and the orders relating to claiming the difference of salary in cash from 01.06.2021 to 31.08.2021 in the Revised Pay Scales, 2020 and payment of arrears shall be issued separately. The arrears for the period from 01.04.2021 to 31.05.2021 which will be paid during the financial year 2021-22 will be issued separately on receipt of the orders from the Government.
- The matter has been examined carefully and it is hereby ordered that the difference of pay in cash from 01.06.2021 to 31.08.2021(3 months) i.e., from June,2021 to August,2021 shall be paid in three equal installments starting from December, 2021 in the Revised Pay Scales, 2020, and the arrears for the period from 01.04.2021 to 31.05.2021, will be paid during the financial year 2021-22 which will be issued separately on receipt of orders from the Government and the salary in the Revised Pay Scales, 2020.
- 5) All the Associate Directors of Research/Associate Deans and other Heads of Offices shall ensure that all the pay fixations approved by the State Audit only are admitted in Revised Pay Scales, 2020.
- All the Heads of Offices are instructed to prepare the difference of pay bills in cash from June,2021 to August,2021 in three equal installments starting from December, 2021 onwards in the Revised Pay Scales, 2020 of Non-Teaching employees. The arrears for the period from 01.04.2021 to 31.05.2021, will be paid during the financial year 2021-22 for which orders will be issued separately on receipt of orders from the Government and all the Asst. Comptrollers are instructed to admit the bills.
- 7) All the Asst. Comptrollers are instructed to seek transfer of funds soon after the receipt of bills from the concerned Heads of the Offices.

8) All the Drawing Officers / Asst. Comptrollers are instructed to adhere to the above instructions scrupulously, without any deviation and the other instructions/orders issued vide reference 2nd cited shall continue to apply.
