**ORDER:**

In the Government order 3<sup>rd</sup> read above, based on the recommendations of First Pay Revision Commission, orders were issued implementing the Revised Pay Scales, 2020 to the State Government employees.

2. Government in the reference 1<sup>st</sup> read above, issued orders fixing the eligibility criteria for Air Travel.
3. The First Pay Revision Commission inter alia has recommended for corresponding revision in the eligibility criteria for Air Travel.
4. Government, after careful consideration of the recommendations of the First Pay Revision Commission and in modification of the orders issued in Government order 1<sup>st</sup> read above, hereby revise the existing ceiling on eligibility criteria for Air Travel, as follows;
  - a) All Officers drawing pay in the scale of pay of Rs.96,890 - 1,58,380 and above in the Revised Pay Scales, 2020 shall be eligible to perform journey by Air on official duty
  - b) All India Services Officers and All Heads of Department irrespective of their scale of pay shall be eligible to perform journey by Air on official duty

- c) Secretary to Government may permit their Subordinate Officers upto the level of Deputy Secretary to Government to travel by Air on Official work to any place outside the State, keeping in view the exigencies of work
- d) Head of Departments may permit Officers not below the rank of Deputy Director to travel by Air outside the State, if the exigencies of work warrant such a relaxation
- e) All India Services Officers who are in Level 15 and above in the Pay Matrix recommended by the 7<sup>th</sup> Central Pay Commission are allowed to travel by Business Class and to the Officers of State Government getting corresponding scale of Rs.1,27,310 - 1,62,070 in the Revised Pay Scales,2020, while other eligible officers are allowed to travel by Economy Class
- f) All other Officers who are eligible for 'travel by Air' shall travel by Economy Class only
- g) The existing provision of eligibility to travel in A.C. I Class by train by such of the employees who are eligible to travel by Air shall continue

5. The existing Telangana Civil Services (Travelling Allowance) Rules, 1996, and other orders issued from time to time thereon shall continue to apply except as provided for in this order.

6. Necessary amendments to the Telangana Civil Services (Travelling Allowance) Rules, 1996 shall be issued in due course.

7. These orders shall come into force with immediate effect.


